#### **SECTION 4 - First Aid Measures**

Inhalation:

Remove exposed individual to fresh air and assist breathing if necessary. Seek medical attention.

#### Eye Contact:

Flush eyes with lukewarm water for 15 minutes. Seek medical attention immediately.

#### Skin:

#### **SECTION 5 - Fire Fighting Measures**

## Alcohol Foam, CO2, Dry Chemical

Keep containers tightly closed. Isolate from heat, electrical equipment, sparks and open flame. Closed containers may explode when exposed to extreme heat. Do not apply to hot surfaces. #### Handling:
